


AXLE LIFT

Note: With an EBS installation, the LS2000 valve may no longer be needed to control the lift axle.

The air control for the lift axle can be integrated in to the EBS controls. The EBS controls can include the lift axle control valve (including the exhaust warning whistle).

- Make sure the lift axle is not an EBS/ABS sensed axle.
- If the LS2000 is still used, make sure it does not effect the EBS operation.

VALVE LOAD SETTING INFORMATION

ADR43/04, Section 9; documents the requirements for the lift axle activation.

It is the responsibility of the installer to follow the ADR.

Extract from Section 9:

Example: If a tri-axle suspension fitted with dual tyres has two retractable axles, when running only on the non-retractable axle, the first 'Retractable Axle' must come down no later than when the load imposed on the ground reaches 6.5 tonnes. The second 'Retractable axle' must come down no later than when the load imposed on the ground reaches 13.0 tonnes.

The FKH (KB) fully automatic lift axle control valve (LS2000) has a factory setting of:



3.40 bar (49 PSI) for axle drop pressure.

1.7 bar (25 PSI) for axle lift pressure.

Note: The above pressures are the airbag air pressures

That factory setting (3.4 bar & 1.7 bar) will translate in to different axle loads, depending on what suspension the valve is used.

Please take notice of the additional pressure control valve which needs to be fitted when installing an axle lift with the FUWA KT suspension. See page 5 for more details.





Adjusting Screws:

Screw for setting the pressure for lowering (automatic lowering of the lift axle)









Note: The valve in the photos and the drawings above shows how the valve is to be fitted in the chassis.

The mounting bracket must face to the top.



LIFT VALVE INSTALLATION INFORMATION

ADR42/04, Section 22; documents the requirements for the axle lift warning.

It is the responsibility of the installer to follow the ADR.


Extract from Section 22: "22.2.2 An audible warning device must be sounded as lowering begins as


required by clause 20.4"

"22.2.3 The vehicle must be marked on both sides within 2.0 metres of a transverse vertical plane though the centre-line of the 'Retractable Axle' with

"Warning: Axle(s) may raise or lower automatically".

In reference to the requirement in 22.2.2, an air whistle can be installed in the lift air bag exhaust port of the control valve, as shown in the following photo.





Remove the silencer from port 3 and screw in the whistle (GP-WH-02RK).

In reference to the requirement in 22.2.3, attach the following sticker (FHD-047-Rev2) in a clearly visible position within the appropriate distance (2m) from the lift axle.
